

1982 to July 1983. On the 25th July 1983 his household goods, cash, jewellery and identity card were looted and burnt. For a fortnight stayed in the Camp at Thurstan College and later went to Jaffna. Had made a complaint to Jaffna Police Station. (Ref. 554)

423. **V. Karthigesu, 25/18/A17, Rajasinghe Road, Wattala** - The writers had a milk bar at Premises No. 07, St. Joseph's Street, Colombo 14. During 1983, which was attacked, ransacked and destroyed by a gang of looters on 25th July, 1983. An Entry had been made at Grandpass Police Station. Seeks compensation. (Ref. 555)
424. **Mrs L. Balasundaram, P-50, Polythene Section, Badowita, Mount Lavinia** - Applicant was living with his family at 209, Kehitta, Wattala which was attacked during the riot on 26.07.1983 and housed at Bambalapitiya refugee camp and later went to the Eastern Province in 1985. During riot they have lost their household goods, poultry and cattle. Requests compensation. (Ref. 558)
425. **V. Ratnam, P-46, Polythene Section, Badowita, Mount Lavinia** - The complainant states that on the 25th July 1983 their residence at 106, Sri Panganada Mawatha, Colombo 15, was attacked, they ran away to save their life leaving everything back and took refugee at St. Lucia's Church. After a month they were taken to Bambalapitiya Manickckampillayar Temple with Police escort. When after another when he visited his house to see, he found that his house was looted and damaged. After 06 months they were taken to Mannar. Requests compensation. (Ref. 559)
426. **M. Mahamuny, P. 45, Polythene Section, Badowita, Mount Lavinia** - Applicant was living at Getaloya Estate, Kandy during ethnic violence and lost his belongings was a result of the looting on 26.07.1983. Requests compensation. (Ref. 560)
427. **S. Indra, P. 57, Polythene Section, Badowita, Mount Lavinia** - Applicant was living at NHS, Rawathawatte, Moratuwa, which was looted and burnt on 26.07.1983 during the ethnic violence. Requesting for compensation including assistance to obtain plot of land for living. (Ref. 561)
428. **P. Veeran, P-31, Polythene Section, Badowita, Mount Lavinia** - Complainant states that all his belongings were looted during the ethnic riots. He requests compensation as well as a plot of land to live in. (Ref. 562)
429. **V. Rangunathan, P-58, Polythene Section, Badowita, Mount Lavinia** - Applicant is describing of an incident when his wife was affected during ethnic violence on 25.07.1983 (before the marriage) and all the household items were looted during the riots. Seeks compensation including a plot of land for shelter. (Ref. 563)
430. **T. Periyannan, P 37, Polythene Section, Badowita, Mount Lavinia** - Applicant was living at Padukka during 1983 ethnic violence, ended up at Bambalapitiya

refugee camp. Requesting compensation for the lost and plot of land or house for a better living. (*Ref. 564*)

431. **S. V. M. Ganeshan, Talapiyannawa Estate Ampitiya** - The complainant had been ad cultivator cum partner in five firms and consultant of M/s Spenceers Apperels Ltd. at Maharagama. His permanent address at above was burnt during the violence. On 26.07.1983 a mob came inside the house and looted all his belongings. They were in a camp at Peradeniya University. After about 20 days when they returned to the house, he found the house was burnt. Requests compensation for the losses. (*Ref. 568*)
432. **C. S. Edward, 64/1, Mayura Place, Colombo 06** - The writer states that in the ethnic violence of 23.07.1983 his house, property and all his belongings were burnt by a mob of about 70 people. He had made an Entry at Dehiwela Police Station. Requests compensation (*Ref. 569*)
433. **K. Sunil, P 38, Polythene Section, Badowita, Mount Lavinia** - Applicant was living at Padukka during 1983 violence, he was affected during this time became inmate of the Bambalapitiya refugee camp. Requesting for plot of land or house to live in. (*Ref. 573*)
434. **M. Raja, P. 55, Polythene Section, Badowita, Mount Lavinia** - The complainant states that he was residing at 363/1, Welikada, Rajagiriya at the time ethnic violence in July 1983. In July 1983 to safeguard his life (he was a bachelor and he was looking after his mother, brothers and sisters) he left to a Sinhalese friend's house leaving his household things and personal belongings. After about two weeks when he came back looked, he found that all his things were looted. Later he had married a poor girl from Wellawatte Ranjan Wijeratnapura. His neighbours who did not like his marriage had chased both of them. They were dwelling on the pavement for few days and after that with the help and recommendation of a council member namely Mr. W. R. Lal Chandrasena they put up a hut on the seaboard of Ramakrishna Road, Wellawatte. Requests compensation. (*Ref. 574*)
435. **M. Selvaraj, P-30, Polythene Section, 6th Division, Badowita, Mount Lavinia** - The complainant states that he was residing at High Level Road, Wellawatte. Due to the ethnic violence on 23.07.1983 all his belongings were destroyed. He and his family had taken refuge at Saraswathy Hall Welfare Centre. He also had erected a hut as mentioned in the File No. 574, Seeks compensation. (*Ref. 575*)
436. **Mrs. K. P. Wijayaletchumy, 3rd Division, Attidiya, Badowita, Mount Lavinia** - She was living at 424/48, Elvitigala Mawatha, Colombo 05 and was engaged in business, which was burnt down during the riots. She requests compensation and land or house to live in. (*Ref. 576*)
437. **M. Anthony, P-60, Polythene Section, Badowita, Mount Lavinia** - Applicant was living at Radamalwate, Puwakpitiya, Ratnapura was affected by the racial

- riot of 26.07.1983, displaced to the Bambalapitiya Camp. Requests for plot of land or house to live in. (*Ref. 577*)
438. **V. Nagamuththu, P-44, Polythene Section, Badowita, Mount Lavinia** - States that he was living in Main Street, Elpitiya, affected by the racial riot in 25th July 1983 and sent to Bambalapitiya refugee camp. Requesting for compensation and land or house to live in. (*Ref. 578*)
439. **M. Kanthimathy, Badowita, Mount Lavinia** - States that all her belongings were looted during the riots and the family got, displaced as a result. Seeking compensation for losses in 1983 and plot of land or house to live in. (*Ref. 579*)
440. **M. Manamohan, Badowita, Mount Lavinia** - States that he was living at 428/36, Elvitigala Mawatha, Colombo 05 and affected by racial riot on 27.07.1983 and became the inmate of the Bambalapitiya refugee camp. Requests compensation. (*Ref. 580*)
441. **P. Ramasamy, Polythene Section, Attidiya, Badowita, Mount Lavinia** - States that he was living at Hewagetta in 1983, affected by the racial riot taken to Vavuniya and back to Colombo in 1990. Requests compensation. (*Ref. 581*)
442. **Mrs. J. A. F. Rajamani, Polythene Section, Badowita, Mount Lavinia** - State that she and her family were displaced from Wattala to Mannar then India and now living in Mount - Lavinia. She requests for a plot of land or house to live in. (*Ref. 582*)
443. **Mrs. S Mariyayee, Polythene Section, Badowita, Mount Lavinia** - States that she and her family were displaced from Salavai Estate to Ratmalana Refugee Camp and now living in Mount Lavinia. She requests for land or house to live in. (*Ref. 583*)
444. **Mrs. K. Letchumy P-54, Polythene Section, Badowita, Mount Lavinia** - States that she and her family were displaced from Ibbawatte, Colombo 15 to Ratmalana Refugee Camp then to Batticaloa and now living in Mount Lavinia. She requests for land or house to live in. (*Ref. 584*)
445. **A. Palaniyandy, P.40, Polythene Section, Badowita, Mount Lavinia** - States that he was living in Kurunegala during the violence in 1983 displaced to the refugee camp and later to the camp in Mankulam. Due to the problems faced in Mankulam returned to Colombo in 1990. Requesting compensation for land or house to live in. (*Ref. 585*)
446. **P. Selvakumar, Polythene Section, Badowita, Mount Lavinia** - States that he was living at Chundukuli and displaced to Polgahawela in 1983 due to the disturbances. From there they went to Mannar and returned to Colombo in 1990. Requesting compensation for losses incurred in 1983 and request for plot of land or house to live in. (*Ref. 586*)

447. **K. Kanapathy, P-54, Badowita, Mount Lavinia** - States that he was living at Dickovita, Bovitte during 1983 and affected by the violence on 24.07.1983 and then shifted to several refugee camps in Colombo till they were sent to Batticaloa in 1985. Due to the war situation in that area they returned to Colombo in 1990. Requesting for compensation (1983) and a plot of land or house to live in. (Ref. 587)
448. **Sinniah Kulasegaram, 30, Galewatte Road, Katugastota** - States that he was living with his family at the above address, were forced to leave this house in 27.07.1983 as a result of the ethnic violence. His entire household items were looted. Requests compensation. (Ref. 588)
449. **S. Subramaniam, 9A., Gnanatilake Mw. Mabola, Wattala** - States that he was living at 89/4, Galmangodawatte, Wattala engaged in furniture business, and on 23.07.1983 during the riot his furniture was looted while transporting between Kegalle and Mawanella and their house too was looted. Household goods also lost. Requests compensation (Ref. 590)
450. **P. S. Ratnakumar, 47/12, Rajasinghe Mw. Oruthen Place, Avissawella** - States that he was living with his parents at Ayar Estate, Irithapola, Dummodera, Wega during the ethnic violence, left the house on 23.07.1983 when the looters came to attack the house, after looting the house, they burnt the house and the poultry farm. Requests compensation. (Ref. 591)
451. **S. Arumugam, F-01, Navagampura, Sec 2, Colombo 14** - He was living at 950, Waragoda Road, Galagodawatte, Kelaniya. His house was attacked and looted on 27.07.1983. He was taken to the camp by the Police and sustained injuries when the vehicle skidded off the road and he got treated for the injuries. He requests compensation. (Ref. 592)
452. **R. S. Mohanadas, 72/4A, Mandandawala, Matale** - States that he was living at 25A, Pillaiyar Kovil Road, Matale, which was looted on 29.07.1983 during the racial riot and he had lost his household things, Requests compensation. (Ref. 594)
453. **D. Shadhadcharan, Vehakutty Walavu, Navaly, Manipay** - States that his son worked under Skanska under the Mahaweli Development Project was allegedly been assaulted by some employees of the same firm during 1983 riots and finally he died at Gampola Hospital. He seeks compensation. (Ref. 595)
454. **R. Devananth, 9, Mahadawatta Road, Matale** - States his house was burnt during 1983 July Civil Disturbances. He requests compensation. (Ref. 597)
455. **A. Thiyagarajah, Nathna Tailor Shop, Kande Nuwara, Alwatte, Matale** - States that his shop at the above address, was looted and burnt during the riots. Requests compensaiton. (Ref. 598)

456. **S. Sangar, Polethene Section, 6th Division, Badowitta, Mount Lavinia** - He was living at Pillayar Kovil, Galgamuwa during the 1983 riot, and on 25.07.1983 his house was destroyed along with household items motor cycle, jewelleries etc. Became inmates of the Bambalapitiya refugee camp. Requests compensation. (Ref. 599)
457. **P. Jeganathan, No. 48, 3rd Lane, Polethene House, Badowitte, Mount Lavinia**, States that he was living at C. P. C. Quarters, 488-G, Bluemendhal Road, Colombo 14, working at Premier Engineers Ltd. as security guard. Hearing the news on 23.08.1983, that a mob is approaching this area he left the house with his family with a suitcase, which was waylaid on the way and ended up[ at the Ratmalana refugee camp. Requests compensation. (Ref. 600)
458. **S. Tharmalingam, P-39, Polythene Section, 6th Division, Badowita, Mount Lavinia** - States that he was residing at 25/26, Mariakade, Maradana, On 26.07.1983 as he was affected by the ethnic violence he and his family had taken refugee at Bambalapitiya Saraswathy Hall Camp. He had lost clothes, household furniture and his belongings. After that they had left to North on 05.01.1985. Requests compensation. (Ref. 603)
459. **C. Arumugam, 15/I-L, 19th Lane, Stace Road, Navagampura, Colombo 14** - States that he was running a Hotel bearing Assessment No. 56, New Kelani Road, Wellampitiya during the time of the incident in 1983. On the 26th July 1983 had come to the Hotel as usual. Whilst he was above to open the Hotel he had seen about 15 to 20 people with dangerous weapons such as iron rods, knives and poles in their hands and approaching towards his business place. As he saw them he had run away and taken shelter at a house nearby . On the following day he had come and inspected the place and found all his stock in trade, fixtures and fittings were looted. After that he had gone to his native place Gonagoda, Deltota, Seeks compensation (Ref. 604)
460. **Mrs. K. Jeevamalar, 54, Kirigalpotte, Palapathwala, Matale** - States that her house was set on fire with all the clothes, furniture, radio, T. V. Sewing Machine, Jewellery, Silver and Brass Utensils on 23.07.1983 during the ethnic violence . She had lost everything including the hose and belongings, She seeks relief. (Ref. 605)
461. **S. P. Ramiah, 30, CSC, Station Road, Hatton** - The complainant states that he was a victim of 1983 July ethnic violence. His residence that was at the 6th Mile Post, Kandapola, he with wife and children had run away into Court Lodge Estate for their safety. Later they had gone to the Refugee Camp at Kandapola Estate. As they were scared of retuning to their residence they went to India. They spent 04 months in a refugee camp. He returned to Sri Lanka leaving his family in India and he continued his service as a Principal at Kandapola Methodist Tamil Vidyalaya. As his wife and children had overstayed in India they are unable to return. If they opt to return they have to

face a heavy penalty. He seeks compensation and requests whether the Commission could regularize if they travel to the country with India Passport. (Ref. 607)

462. **S. P. Vadivel, Gangodakumbura, Pallepanguwa, Lunugala** - States that his business premises known as 'Kalyani Stores', 188, Main Street, Lunugala was attacked during the July 1983 violence. Requests compensation. (Ref. 608)
463. **Mrs. S. Selvam, Mahawatte Farm, Dankotuwa** - States that she lost all her belongings during the riots in 1983. She requests compensation for the losses (Ref. 609)
464. **T. Jegatheeswaran, 85/2, Pickerings Road, Colombo 13** - The complainant states that his residence was completely burnt down with goods on July 25th 1983 due to the ethnic violence. He seeks compensation to re-establish his house. (Ref. 610)
465. **T. Gengatharan, Ilakandy, Alvai East, Alvai** - He was living in the office quarters of Deta Tamil School. At about 10.00 p. m. on the night of 26.07.1983 four people came running and threw stones at him. He fell down and they set fire to body and he was at the Ratnapura hospital and was unconscious for 13 days. He lost his belongings including jewellery. Requests relief. (Ref. 611)
466. **R. S. Keerthisingam, 154, Kotahena Road, Colombo 13** - States that his residence at 114, Thelangapatha Road, Wattala and the vehicle were set on fire on the 24th July 1983. He seeks compensation (Ref. 613)
467. **M. Renganathan, 390, Balagolle, Kengalla** - The complainant states that he is the husband of Mrs. Maheswari Renganathan who is daughter of late Mr. Suppiah Shinniah. At the time of the ethnic violence that took place on 27.07.1983 they were residing at 211, Lower Street, Badulla - The premises were used as Textile Shop. On the day of the incident the shop was set on fire and completely destroyed. The premises and the stock in trade were lost. He seeks compensation. (Ref. 614)
468. **Palaniandy Sivarajah, 10, Kathirsan Kovil Road, Talawakelle** - The complainant states that his residence at 12, Gampola Back Road, Nawalapitiya was looted and set on fire on July 27, 1983. He seeks compensation for the losses incurred by him. (Ref. 617)
469. **Mrs. A. Maheswari, 60/1, Tientsin Bazaar, Bogawantalawa**, - States that they were running on Oilman Stores named "Renuka Stores" at No. 40, Talgaswela, Nagoda during the time of the ethnic violence. Her house, shop and its belongings were set on fire and things were looted by a mob on 25.07.1983. Seeks compensation. (Ref. 618)

470. **V. Palaniyandi, 41A, Rosita Bazaar, Kotagala** - The complainant states that he was running Tailoring and Garment shop at 32, Neboda Road, Matugama at the time of incident. On 25.07.1983 at about 2.00 p. m. a crowd of about 150 people were came marching and shouting that 'Tamil should be killed'. 'Tamil should be beaten up and set fire on them'. They got scared ran immediately through the rear side of the shop to save their lives. After that they had set fire to the shop. Requests compensation (Ref. 623)
471. **S. Thanabalasingam, 16/8, Bandaranaike Square, Talawakelle** - States that he was residing with his family at 289, Averiwatta Road, Galmangoda, Wattala. On 24.07.1983 an unidentifiable mob had come at about 10 in the morning and chased them away from the house. They had to take refugee at Wattala Police and through them then had gone to Gampaha refugee camp. After two weeks when they went and saw the house they found that their resident was completely empty. Their all belongings had been looted. He seeks compensation. (Ref. 625)
472. **S. M. Sinnakkaruppan, 60/9, Tientsin Bazaar, Bogawantalawa** - The complainant states that he was employed at PISS Iyangan Nadar & Co., No. 08, Matara Road, Galle, and his family was residing at Talangaha Estate, Galle. They had lost their all belongings during the ethnic violence of 1983 and had taken refugee at Kathiresan Temple, Kittangi, Galle. Later they had left to Bogawantalawa where they reside now. Seeks compensation (Ref. 627)
473. **G. Kusalarajah, 20, "Rosellegama", Station Road, Pusella** - States that after his marriage he was living with father-in-law who had a shop at Hatton and a house at Lunugala. At the time of the incident his wife was staying in Lunugala house for her first delivery and he was working at CTB Hatton. On 27.07.1983 his father-in-law's house, shop and his belongings were looted set on fire and destroyed due to the ethnic violence that prevailed in the country. Requests compensation. (Ref. 629)
474. **M. K. Nadarajah, 21, City Plaza, Hatton** - The complainant states that his house was looted and set on fire on the 27th July 1983. The place of occurrence was 8/2, Meegawatte Road, Wattala. He had lost jewellery, household and also his brother had died on 29.07.1983 due to the incident. He seeks compensation. (Ref. 632)
475. **K. K. Ramachandram, Morar Estate, Bogawantalawa** - The complainant states that his residence was looted and set on fire on the 25th July 1983. The place of occurrence was 471, Galle Road, Colombo 04. He seeks compensation. (Ref. 634)
476. **P. Santhakumar, 6, Wanigasekerapura, Kottagala** - The complainant states they were beaten up and robbed all of their belongings by the majority community at 42, Lower King's Street, Badulla on the 27.07.1983. Seeks compensation. (Ref. 636)

477. **M. Thuraisamy, 3, Vanigasekarapura, Kottegala** - States that he was running a textile business on partnership with two other under the trade name 'Excellence' at 16, Bristol Street, Fort, Colombo 01 at the time of the violence. On 25.07.1983 at about 9.00 a. m. a gang of mishchief makers had forcibly entered his shop, chased him out, looted his shop and set fire to it. He seeks compensation. (Ref. 640)
478. **A. Suppiah, 43, Navagammanaya, Inguruoya, Nawalapitiya**, - The complainant states that he was running a business under the trade name 'Kala Traders' at 1, Dolasbage Road, Nawalapitiya at the time of the ethnic violence. On 27.07.1983 at about 11.00 a.m an unidentifiable people had come and looted all his stock in trades his belongings and set on fire to premises. Seeks compensation. (Ref. 641)
479. **S. Seenivasagam, 44, High Level Road, Maharagama**, - States that he was the owner of the M/s Raja Jewellery situated at No. 97, High Level Road, Maharagama, 'Raja Lodge' at No. 44, High Level Road, Maharagama and his house at No. 122, Old Road, Pannipitiya, Maharagama. On 25.07.1983 at about 9.30 a. m. while they were in the shop they heard about the riot they closed the shop and went to their residence. Whilst they were making arrangements to leave the house under fear and save the lives a mob had come and surrounded their house. The mob with knives, swords, iron bars and deadly weapon started attacking the house and looted their jewellery and belongings. His brother-in-law had been stabbed when he had run to save himself. Later he had come to know that his lodge and Raja Jewellery Shop had also been looted and completely destroyed. Seeks compensation (Ref. 642)
480. **Mrs. S. Ponniah, 296/6, Konanagoda, Deltota**- The complainant states that his shop that was at 12/1, New Kelani Road, Wellampitiya was set on fire and things were looted on 27.07.1983. He sees compensation. (Ref. 643)
481. **S. Pararajasekaram, Sivan Kovil Veedi, Sinna Oorani, Batticaloa** - States that he was residing at No. 85, Swama Chittiya Road, Colombo 14. During 1983 ethnic violence an unidentifiable mob had entered his house assaulted them, looted their jewellery, factory and their resident were destroyed . Seeks compensation. (Ref. 644)
482. **Mrs. T. Karuppiyah, 89/30, Kudugala Road, Wattedgama** - The writer's husband was chief clerk at Endane Estate, Kahawatte, During the communal riots of 1981 - in July his official quarters was burnt. His entire personal belongings and the refrigerator were destroyed. Requests compensation. (Ref. 645)
483. **P. Rengasamy, 8, 1st Lane, Soyesagala Road, Behind Hospital, Nawalapitiya** - The complainant states that he was conducting a business at No. 58, Kotmale Road, Nawalapitiya. On 27.07.1983 his business premises was attacked and set on fire. He had reported the incident to the G. S. He seeks compensation. (Ref. 647)



484. **M. Subramaniam, 41/10, Talapiyannawa, Ampitiya**, -Applicant was living with his family at the above address ; who were force to leave the house for safety on 27.07.1983 due to the ethnic violence. and stayed at the Peradeniya University Camp. Their house and cattle shed were completely burnt. Requesting for compensation (Ref. 649)
485. **K. Jayaraj, 60, Shoe Road, Colombo 13** - The writer had a shop at No. 64, Dam Street, Colombo 12 named 'Jaya Trading selling' paints and chemicals. With the outbreak of communal riots of July 1983 violence took place, premise was set on fire and lost entire goods. Seeks compensation for the losses. (Ref. 650)
486. **K. Namasivayam, 131/4, Centre Road, Mattakuliya, Colombo 15** - Applicant was running a Mill at Imputuwelgoda, Kelaniya, which was burnt down on 25.07 1983 during the riot along with three houses, and motor vehicles, thereby he incurred a heavy loss. Requests compensation. (Ref. 651)
487. **Mrs. J. Gunaratnam, C/4, F-5, Armour Street Flats, Colombo 12** - Applicant was living at 11, Albion Place, Colombo 09 during 1983 communal riots, when a group of looters came to attack their house. they fled for safety to Dematagoda Police where they refused to accept the Entry, and to the Thurstan College Camp and to Jaffna by ship. They lost the furniture, household goods, jewelleryes etc. Requests compensation. (Ref. 652)
488. **R. Thillaivasagam, Narangalla Estate, Kandegedera, Badulla** - Applicant is the President of the Hindu Association who report the damages caused to the 100 years old temple 'Sri Kathir Velayutha Swamy Kovil', during the ethnic violence in 1983 of which two wedding halls have been rebuilt by REPIA. Requests compensation. (Ref. 656)
489. **K. Balachandran, 43, Oliyamandiya, Badulla** - States that he was living with father-in-Law's family at No. 43, Oliyamandia, Badulla - On 27.07.1983 at about 23.30 hrs Somapala, Mashal Appuge Bandu who lived below his house had come threaten to kill them. Along with him several others also had entered his house and threatened them. On that same night about ten people including Somapala carrying a container with petrol and Bandu come and poured the petrol to the house. Under fear he and his family left the house and gone to the camp. On the next day when he went and saw the house he found that his housed was partially gutted and the entire household goods were looted and burnt. He seeks compensation. (Ref. 657)
490. **Mrs. M. Sundaram, 50, Passara Road, Pelgahatenne** - She says that the incident had happened at 280/1, Mudiyangkanana Road, Badulla. Her husband Kuppamuthu Sundaram ; her sons Sundaram Ganeshan and Sundaram Rajeswaran ; Son-in-Law Velayutham Nagaratnam were shot dead by unknown people. Her residence and its belongings were totally destroyed by fire. She requests compensation. (Ref. 658)

491. **V. Mahalingam, 1/1D, Kanupelala Road, Mylagastenne, Badulla** - The complainant states that his premises had been attacked on 27.07.1983 by a mob and looted their belongings including jewellery. As a result they had lost all their belongings. He seeks compensation. (Ref. 659)
492. **S. Sornam, 46, Dalada Ela Road, Salgaduwatte, Kanupalalla, Badulla** - Applicant was living at Naragala Division, Kandegedera. A gang of looters entered the house on 27.07.1983, during ethnic violence and taken away entire belongings, Requests compensation (Ref. 660)
493. **K. Manoharan, Wewessa Group. Ammani, (W/o Ratnma) No. 21, Sivaguru Stores, Spring Valley, Badulla** - States that they had a house at First Division, Spring Valley Group, Spring Valley and a boutique named Sivaguru Stores at 21, Spring Valley, on 26.07.1983 their boutique had been looted and destroyed by fire, And on 28.07.1983 the house had been burgled. Seeks compensation. (Ref. 668)

581. **S. Rangaraj, No. 67/1, Rattota, St. Matale** - States that he was living in the above address. His house was looted including 120Kgs of pepper and 15 bushels of paddy that were in the house during the 1983 disturbance (Ref. 763)
582. **M. Asokumar, Yathanside Estate, Kotagala** - Applicant was working at Sri Alaimagal Motor Stores at 367/4, Sri Sangaraja Mawatha, Colombo 10. On 27th July, 1983 he was on his way to kotagala, when he was surrounded by a

gang at Peradeniya bridge he was assaulted and robbed his personal belongings. He made a police complaint. (Ref. 764)

583. **M. Balasubramaniam, No. 10, Oorugala, Medamahanuwara** - States that he was affected by the 1983 riots and had been in a refugee camp. (Ref. 765)
584. **M. Chelliah, No. 20/B, Circular Road, Kaludawela, Matale** - States that his house was burnt and he had lost his belongings including clothes and jewellery. (Ref. 766)
585. **M. Paappathy, No. 23, Dickliyawatte, Aluvihare, Matale** - Applicant was living in a rented out house at No. 5, Doragamuwa Road, Wattegama with her husband and two daughters and a son. During 1983 July when they were at home, a crowd of people came and chased them away from the house. They had to stay in a temple and later when they came back after 4-5 days they found that there were nothing in the house. All household items were looted. applicant's husband died on 26.12.1991. (Ref. 768)
586. **R. Jayaram, No. 50/1, Pansala Road, Bandarawela**, The applicant was living at No. 30, North Kepilawela, Bandarawela and was engaged in business. On 27.07.1983 during the racial riots the family had to flee from the house and stayed at the St. Josephs' refugee camp for safety. On return they found their household items were looted. A police entry had been made about the loss. (Ref. 770)
587. **Mrs. S. Shanmugavadivu, No. 21, Badulla Road, Bandarawela** - Applicant was living with her family at the address . During the communal disturbance of July 1983, their house broken and looted on 27.07.1983 incurring a heavy loss. Applicant had made in loan application to REPPIA. (Ref. 771)
588. **R. Krishnan, No. 15/3, Lower King's Street, Badulla** - Applicant was living at the address given during 1983 disturbance. They had to flee from the house for safety and on their return to the house they found that their belongings were looted and some of the items were found burnt along the roadside. They have made a police entry. (Ref. 772)
589. **Mrs. T. Rajewary, Raja Stores, Lunuwila** - States that her husband was engaged in business at No. 10, Raja Sotres, Lunuwatte, On 26.07.1983 the business premises were looted and burnt incurring heavy losses. Police entry has been made. (Ref. 774)
590. **K. Nadarajah, No. 53, Pansala Road, Bandarawela** - Applicant was running a business establishment at No. 253, Badulla Road, Bandarawela. On 28.07.1983 during the disturbance he had to leave the business premises and sought

refugee at St. Joseph's College refugee camp. The stock-in-trade in the shop all looted. He had made an entry at the Police. (Ref. 775)

591. **Mrs. K. Balasingam, No. 158, Amunuwellampitiya, Badulla** - States that she was living with her family at 38/5, Lower King Street, Badulla in 1983. On 27.07.1983, a violent mob came to the house and chased the inmates of the house, looted the household goods, Complainant had made an entry at the Police of the losses. (Ref. 776)
592. **S. Ganeshamoorthy, No. 158, Amunuwellampitiya, Badulla** - States that he was living with the family at 230/1, Muthiyangana, Rajamaha Vihara, Badulla in 1983. On 27.07.1983, a violent mob came to the house and chased the inmates of the house, looted the household goods. Complainant could not make an entry at the Police through fear. (Ref. 777)
593. **S. Kandasamy, Egodatenna Kovil, Soranatota, Badulla** - Applicant was living at the address given. On 27.07.1983, a violent mob came to the house and chased the inmates of the house, looted the household goods, Complainant had made an entry of the Police of the losses. (Ref. 778)
594. **Mrs. S. Eswariammal, Egodatenna Kovil, Soranatota, Badulla** - States on 27th July, 1983 around 8.30 p. m. about 25 persons from the same village came and attacked her house. Through fear they fled to the nearby jungle and spend three days in the forest. On 30th July when they returned home to find their house was looted and set on fire, completely burnt. They had to stay in a cattle shed for few days and repaired a portion of the house. (Ref. 779)
595. **Mrs. S. Sivapackiyam, No. 223, Nagapattana, Vinithagama, Badulla** - in her statement states that on 27th July 1983 around 10 to 15 rioters came and threatened them stating that if they don't leave the place they would be killed. Through fear she had to leave the house with her late husband and small girls to a nearby forest and stayed overnight in the jungle. When the rioters tried to set fire to the house, the Sinhalese neighbours prevented them from doing so. According to her she did not go the police to make an entry as she feared to go to the Police Station. She had lost all her household belongings which were looted by the rioters. (Ref. 780)
596. **V. K. Devaraj, Vellangolla, LD, Badulla** - States that he was living with his family at 3/1, Kumarasinghe Street, Badulla at which time July 1983, his house was looted by a gang of ruffians after chasing them away from the house. He could not make police entry at that time due to fear. (Ref. 781)

597. **N. Thiruchelvam, No. 2, Main Street, Pannakkadduwa**, -Applicant states that he was living in Pallekadduwa and was engaged in business "Selvam Traders" doing textiles business. On 29.07.1983 a gang of youngsters looted his shop and he has lost the stock-in-trade items. He had made an entry at the Police about the loss of items. (Ref. 782)
598. **S. M. Ratnasabapathy, No. 11, Kumarasinghe Road, Badulla** - Applicant was living with his family and engaged in business at 237/B, Lower Street, Badulla which was looted and burnt on 27 July, 1983 during the communal violence. He had lost his entire assets due to this incident. He and his family got displaced and had to be at the refugee camp in Kayts. He had lodged and entry at Kayts Police. (Ref. 783)
599. **S. Kumarasamy, No. 171, Mawalgoda, Hali-Ela**, -Applicant was living at the address given during July, 1983 and he lost his suitcase with clothes and jewellery due to the violence. He had made a Police entry. Seeks compensation. (Ref. 784)
600. **Mrs. Kulasundaraiammal, No. 21, Poonagala Road, Bandarawela** - Applicant was living at 232, Badulla Road, Bandarawela, in 1983. On 27th July 1983 her house was looted and set fire. She says that she has lost everything from the house. A Police entry was made about the loss. (Ref. 785)
601. **M. S. Nithiyanthan, No. 35/9A., Kanda Road, Welimada Road, Bandarawela** - Applicant was living at 4/11, Haputale Road, Bandarawela which was looted and burnt on the night of 27.07.1983 by a gang of looters having forced the inmates of the house to leave the house. They had to flee to a neighbouring tea estate and stayed the night in the estate. The following morning they went to St. Joseph's refugee camp with the help of the police. (Ref. 786)
602. **R. Kandasamy, No. 136/10, Dharma Vijaya Mawatha, Bandarawela** - Applicant was running a jewellery shop at No. 94, Main Street, Bandarawela by the name "Ratna Jewellery". The shop was broken open, looted and set on fire on 29.07.1983. Applicant and family had to be in the refugee camp for nearly 10 days. He had made an entry at the Police about the loss of his jewellery items. (Ref. 787)
603. **R. Kanagaraj, No. 10/2, Haputale road, Bandarawela**, - Applicant was running a jewellery shop at No. 94, Main Street, Bandarawela by the name "Ratna Jewellery" (same as complaint No. 787). The shop was broke open, looted and set fire on 29.07.1983. Applicant and family had to be in the refugee camp for nearly 10 days. He had made an entry at the Police about the loss of his jewellery items. (Ref. 788)

604. **P. Jeganathan, Medapatana, Ellababula Ela** - The complainant was a farmer and also and poultry farm. On 27.07.1983 when there was ethnic violence he left the place leaving all his stock and poultry and lived elsewhere for safety. After three days when he returned to his house to find that his agriculture items and poultry have been looted. He made a complaint to the Grama Sevaka (Ref. 789)
605. **Mrs. R. N. Veeriah, Hugoland Estate, Lunuwatte** - Applicant was living at Hugoland Estate, Lunuwatte, Her husband was running a saloon No. 8, Lunuwatte Bazaar, Lunuwatte which was completely looted and set fire on 26.07.1983. Thereafter the husband could not continue the running of the saloon, The family is now finding difficult for existence because of the loss involved. (Ref. 790)
606. **A. Paramanathan, No. 19, Sangabo Mawatha, Passara** - Applicant was living at 23, Sangabo Mawatha and engaged in business at "E. V. Arumugam", 307, Main Street, Passara doing business of oilman goods as well as having a jewellery pawn shop. On 28.07.1983, during the riot the shop was looted and set on fire, Applicant had to be displaced and was in his native place, Kaysts, He had made an entry at Kaysts Police about the losses. (Ref. 791)
607. **P. Sritharan, No. 1, Main Street, Bandarawela** - Applicant was engaged in business along with his father. They were residing at 16/1A., Haputale Street, Bandarawela and the business "Sri Vinayaga Stores" at No. 31, Main Street, Bandarawela. On hearing that violence broke and business premises are being attacked applicant along with his father hurriedly locked up the shop and the whole family went and stayed in a Kovil and later in the refugee camp at St. Joseph's College. After three days when they went to see the shop, all items in the shop had been removed and lost their household items as well. They made a police entry of the losses. (Ref. 792)
608. **Miss D. Janaki Hopton Group, Ambalangoda Division, Passara** - Applicant was living at 95A, Main Street, Lunugala which was also a shop. The shop was looted and set on fire on the day of violence took place in this area, July 1983. Applicant stayed with the workers in a nearby estate and returned to her shop to find all her things were lost. (Ref. 793)
609. **D. Vivekanadan, Uma Vilas, 26th Mile Post, Lunugala** - Applicant was living at the given address. On 28th July, 1983 the rioters had damaged the house and also looted the things in the house. He had made an entry at the Police. (Ref. 794)

610. **V. Navaratnam, No. 41, Badulla Road, Hali-ela** - Applicant was living at 12/16, Badulla Road, Hali-Ela and was engaged in business at 14, Badulla Road, Hali-Ela. During the riots both the house and business premises were damaged and looted including vehicles bearing No. 33 Sri 9796 and 24 Sri 873. Applicant and his family had to be in the refugee camp. (Ref. 795)
611. **Miss A. D. S. Julian, Polaththawa, Lunugala** - States that she is 47 years. She lost her parents and now living with her elder sister and a younger sister. None of them are married. They were living at 52, Polathawala, Lunugala which house was looted during the July, 1983 riots. In addition to the household items lost, they have lost the pawned jewellery items as the pawn shop too were burnt down (Ref. 796)
612. **Mrs. S. Sinnammah, No. 241/15, Rock Hill, Badulla**, -Applicant was living at 280, Muthiyangana Road, Badulla with her children. On 27.07.1983 during the riots, they had to flee from the house after hearing gun shots. Applicant while hiding in the nearby sugar cane plot was able to see the gang throwing bombs and setting fire to the house. With the help of the Police they were taken to the refugee camp. They have made an entry at the Police. (Ref. 797)
613. **Mrs. S. Alagumalai, No. 3/6, Jambugasmawatha, Badulla** - Applicant was living at the given address which was looted on 27.07.1983 during communal violence. Have made an entry at the Police. (Ref. 798)
614. **K. Govindasamy, No. 1/24A, Jambugasmawatha, Badulla** - applicant was living at 3/3, Postal Street, Badulla and was engaged in jewellery business at "Shanthi Jewellers". Lower Street, Badulla which was looted and goods and tools belongings to the shop were lost. Applicant was living in a refugee camp for some time. He had made an entry at the Police about the loss. (Ref. 799)
615. **Mrs J. R. Fernando No. 3/6, Jambugasmawatha, Mailagastenna, Badulla** - Applicant was living at the given address which premises was looted and set on fire during the communal riots in July, 1983. Applicant was in refugee camp for 14 days. (Ref. 800)
616. **S. Sunderarajah, C/o, Mylvaganam, 24, Bandarawela Road, Hali-Ela** - The complainant states that his family and parents altogether ten in number were living at No. 38/5, Tewatte Road, Wellampiitya, His father was running a boutique in the same premises. The investment was his on 29.07.1983 the boutique was looted and set on fire. He and his children taken refugee at St. Benedict's College. After they had left to Badulla. Seeks compensation. (Ref. 801)



617. **V. Sinnathamby, Hugoland Estate, Lunuwatte** - States that he was living at No. 4/1A, Diyabokandura, Bambarappane and having a groceries too in the same premises during the time of incident. On the day of the incident July, 1983 he had closes the shop and to save himself he had gone to his father's house. On the next day morning had had hear that his house and shop had been destroyed by fire. When he went and saw after three days he found it had been completely destroyed. Seeks compensation. (Ref. 802)
618. **M. Manoharan, Hugoland Estate, Lunuwatte** - The complainant states that he was running a shop named at "Raja Store" at No. 10, Lunuwatta . On 26.07.1983 some unknown people had set fire to it destroying all his belongings. Requests relief. (Ref. 803)
619. **K. Soundrarajan, Hugoland Estate, Lunuwatte** - His house in the estate line was looted and set on fire by hooligans on 27.07.1983 at about 7.30 p. m. Due to the incident he had lost his entire belongings. Seeks compensation. (Ref. 804)
620. **Mrs. R. Asodha, 16, Badulupitiya , Badulla** - The complainant states that she was residing at No. 38/5, Lowerings Road, Badulla. On 27.07.1983 an unknown mob forcibly entered the house ; threatened the inmates ; looted their belongings including jewellery and chased them away. Seeks compensation. (Ref. 805)
621. **V. Alagarajah, Velangolla, Amunuwelapitiya, Badulla** - States that he was residing at No. 42/11, Deiyannawala, Badulla at that time of the incident. On 26 and 27.07.1983 a drunken crowd had come and threatened to kill and chased all the inmates away. They had to leave back all their valuable belongings had hid in the tea estate hill area for about three days, After Police personnel had come and took their jeep to Police Station. Later they boarded into the Batticaloa bus sent them away. Seeks compensation. (Ref. 807)
622. **N. Mathivathanam, Hugoland Estate, Lunuwatte** - The complainant states that his father had a shop named "Mathivathanam Store" at No. 08, Lunuwatte during the time ethnic violence. On 26.07.1983 night a group of hooligans had come, looted and set on fire. All stock in trade and his belongings were lost and destroyed. Request compensation. (Ref. 809)
623. **S. Nagamuthu, No. 23/12, Uyanwatte, Hunwewlla, Badulla** - States that he had a jewellery shop "Lakshmi Jewellers" at No, 67, Bandarawela Road, Hali - Ela at the time of the incident. On 27.07.1983 at about 2.30 p. m. a group of hooligans had come and looted his house and set on fire. Seeks compensation. (Ref. 810)

624. **C. Mohanadas, 24th Mile Post, Kottalbedde, Lunugala**, -The complainant states that on the 29 07 1983 at about 12.30 p. m. a group of people who conversed Sinhala had come and smashed the door, entered their house. The inmates had to flee through the back door for their safety. They had set fire to the house and looted all the properties there in. They took with them their livestock too. Requests compensation. (Ref. 811)
625. **P. Rajarajeswaran, 294, Main Street, Passara**. -States that on the 27.07.1983 a mob with guns had come and set fire the their shop named V. Kathigesu and Co. All the inmates of the shop had run to the nearby Police Station and had taken refuge. Entire establishment was destroyed. All trade in stocks were looted. Seeks compensation. (Ref. 812)
626. **Annavi Letchumana, 118, Bandarawela Road, Badulla** - The complainant states that they had their residence and their shop called "Yogaletchumi Stores" at 219, Lower Street, Badullya. On the 27.07.1983 a large crowd of people had come and attacked the house and the shop and set fire to them. Requests relief. (Ref. 813)
627. **S. Velunathan, 26, Main Street, Namunukula** - States that they were residing and doing business at No. 26, Main Street, Namunukula. Badulla. On the 29.07.1983 some unknown people had come and attacked his business premises. Through fear he and others had run out of the shop. On his return he had found that his shop were looted and burnt. Seeks compensation. (Ref. 814)
628. **K. P. Subramanima, 267, Viharagoda, Badulla** - The complainant states that he and his family were living at 265 and 267, Viharagoda, Badulla. They were using both premises for resident and business. During the ethnic violence in July 1983 a mob of 30 to 40 people who were fully armed had come and destroyed their shop and house causing damaged to property and self. Requests compensation. (Ref. 815)
629. **Mrs. V. Rajanayaki, 46, Devalaya Road, Badulla** - The complainant states that his residence situated at No. 64, Devalaya Road, Badulla was forcibly entered by a group of unknown people with weapons inmates were threatened and chased away. The house had been looted and the things remaining were smashed. The inmates had to flee fear of their lives. Seeks compensation. (Ref. 816)
630. **Mrs. M. Letchumy, 136/6, Lower Street, Badulla** - She was residing at Polkottuwa, Ninandagama, Hindagama, Badulla. On 27.07.1983 her house was set on fire by a mob and she had lost her jewelry household good and personal belongings. She had taken shelter with her family members at Madaya Maha Vidyalaya Badulla Refugee Camp. Requests Compensation. (Ref. 818)

631. **J. Muthlingam, 12-B, Senanayake Mawatha, Bandarawela** - The complainant states that he had a shop at No. 123, Main Street, Bandarawela. On 27.07.1983 a group of unknown people had come set the business on fire, looted things and damaged the premises. Seeks compensation (*Ref. 819*)
632. **V. Sadagopan, C-3/4, Anderson Flats, Colombo 05** - The writer was a Typist attached to the Official Language Department and lived with his family at 16 B, 39th Lane, Colombo 06. On 25th July, 1983 his house was looted. He had fled and was in a refugee camp from where he went to K. K. S. Seeks relief. (*Ref. 820*)
633. **M. Kumaraswamy, 25-C, Bongso Building, Badulupitiya, Badulla** - The complainant states that he was residing at No. 06, Bailey Road, Badulla. On 27.07.1983 his residence was attacked and things such as goldsmith tools were looted. He and his family were saved by neighbours and sent to the camp. Requests compensation. (*Ref. 821*)
634. **N. Rengasamy 250/4, Badulla Road, Bandarawela**, - States he had a shop named "Shri Gowri Stores" at No. 173, Main Street, Bandarawela. On 27.07.1983 he had got to know that his business premises was set on fire and things were looted at about 2.30 p. m. After that he and his family gone to the refugee camp at St. Joseph M. V. Bandarawela. Seeks compensation. (*Ref. 822*)
635. **Mrs. K. Muthumary, 3/9, Pansala Road, Bandarawela** - She says that she was living at No. 8/45, Walasbedde, Bandarawela. On 27.07.1983 thinking that they will be attacked physically left the residence closed and hidden themselves in the jungle. The owner of the house was one perusal. The residence were paying Rs. 100 and month. She had returned on 28.07.1983 had with security and had found that her house was not damaged but her belongings such as jewellery wristwatches and a cassette recorder were missing. Seeks compensation. (*Ref. 823*)
636. **K. Ramalingam, 9th Mile Post, Liyanhalawela, Bandarawela** - States that on the 28.07.1983 shops and houses in the town in flames. Under fear had packed all his valuable things into two suitcases and gone to the kovil. There were about 60 People gathered there with fear. At about 12 o'clock a crowd of 60 people siege the Kovil. Most of victims got injured. He had run with one Perumal to the rear side of Kovil, At that time the crowd set fire to the Kovil. Later they rescued by Major Jeyakumar and taken to St. Joseph College Camp. All his things that were in the suitcase were destroyed by fire. Seeks relief (*Ref. 824*)
637. **S. Rajalingam, 19, Pallakattuwa, Namunukula, Badulla** - The complainant says that they had a house and shop at No. 142, Lower Street, Badulla - At about 13.30 hrs. on the 27.07.1983 a mob of 25 or more persons had come and forces open the shop. He was unable to identify the people. they had removed all the textiles and threw it out. poured petrol on it and set fire. When the shop was ablaze he had left through the rear portion to his dwelling place. After that they had gone to the refugee camp. On the 29th instant he had returned to the

shop and saw it was completely burnt down. He seeks relief form the commission. (Ref. 825)

638. **V. M. Sivasamy, Rookatenne Estate, North Division, Hali-Ela** - He says that he had a shop at No. 61, Bandarawela Road, Hali-Ela. At about 14.30 hrs on the 27.07.1983 some hooligans had come and looted all the things and set the premises on fire. Seeks compensation. (Ref. 826)
639. **S. Jeganathan, 10, Central Saloon, Post Office Road, Hali-Ela** -States that he had a saloon at No. 57, Bandarawela Road, Hali-Ela, on 28.07.1983 at about 10 O'clock in the morning some people had entered his business premises and had set fire to it. All his things that were in side the premises had got burnt. Requests compensation. (Ref. 827)
640. **Mrs. G. Meenambal, 144, Kanupallela Road, Badulla** - The complainant says that they had a house at No. 27, Longdon Road, Badulla .On 28.07.1983 due to the ethnic violence that prevailed in the country they had run for safety leaving their house. When they returned to see the house they found that their belongings that were in the house had been burnt and looted. Seeks compensation. (Ref. 828)
641. **V. K. Ramasamy, 10/3, Haputale Road, Bandarawela** - The compplainant says that he had a house and a business place at No. 10/3, Haputale Road, Bandarawela and No. 93A, Main street, Bandarawela respectively. On the 27.07.1983 some holing they had come in groups. looted the house and went to the shop and looted the business premises and set fire to it. Request relief. (Ref. 829)
642. **N. Chandramohan, Regal Saloon, 7/2, Bandarawela Road, Hali-Ela**, -States that he had a business premises named "Chitra Saloon" at No. 08, Lunuwatte Bazaar, Lunuwatte. On the 26.07.1983 night a mob had come ; broken the premises and had looted the things in it. Seeks compensation. (Ref. 830)
643. **K. Punniyamoorthy, 161A, Gongawala Road, Matale** - The complainant states that his shop premises bearing Nos. 1045, 1045/1, 1045/2, 1054/3 and 1047, Trincomalee Road, Alluvihare, Matale and Nos. 4, 6, 8 Asgiriya Road, Aluvihare, Matale were burnt and damaged during the ethnic violence in July, 1983. Requests relief. (Ref. 831)
644. **R. Sockalingam, (Present claimant Mrs. S. P. Ariyatileke ) 110, Attanagolla Road, Lunugala** -The complainant says that the incident took place at premises No. 110, Attanagolle, Lunugala. On 27.07.1983 at about 10 O'clock in the night he and his members were in the house. There was a sound some one is damaging the fence of the house. Soon after that there were stones pelted on them. Later they saw about 60 people encircling their house and then heard big sound. Then they fearing of their lives they ran away through rear entrance of the house. After some times they saw their house was in smoke. After the crowd had dispersed they had retuned to the house and saw that their house and all

- its belonging were burning. Their son was on the ground lifeless. They had to loose their son in the incident. Seeks compensation. (Ref. 832)
645. **N. Rajendran, 41/2, Kovil Road, Bandarawela.** -States that they were at home when the incident had taken place. On 27.07.1983 at about 2.30 p. m. a mob of hooligans had come to attack them. They had escaped through the backdoor and taken refuge at the church premises. The next day they had left to St. Joseph College Welfare Centre. The other day they had come and seen that their residence had been looted and completely gutted by fire. Seeks relief. (Ref. 833)
646. **K. Velu 49/1, Pansala Road, Bandarawela.** - He says that he was travelling from Colombo to Bandarawela on the day of the incident in July, 1983. Whilst the was travelling the bus had been way laid at Ratnapura he was attacked by unknown crowd and his worn jewellery and cash were robbed. When he had approached the Ratnapura Police to lodge and entry he was chased away by the Police Personnel. Requests compensation (Ref. 834)
647. **G. Sannasy, Regal Saloon, 7-B, Bandarawela Road, Hali-Ela** -The complainant says that he was running a business premises under the name of "Regal Saloon" at 31, Badulla Road, Hali-Ela. The premises were used as business and cum residence. On 27.07.1983 at about 2.00 p. m, a group of trouble makers while set fire to his neighbours premises it had spread to his premises and got destroyed. He could not save anything that was in the premises. Seeks relief. (Ref. 835)
648. **A. Letchuman, 42/12, Deiyannawela Road, Badulla** - The writer had been residing at 13/6, "Signal View", Deiyannawela Road, Badulla when the communal riots started. On 27.07.1983 a large crowd of strangers came threatening towards the house to burn. Through fear they ran to Eldaluwa Estate, From there they were taken to Badulla Central School Refugee camp. All the belongings were missing and the house was damaged. Requests compensation. (Ref. 836)
649. **N. V. Krishnasamy, Dehigolla Kadura, Kandegedara, Hali-Ela** -Applicant was living at the above address with his family and parents during 1983 riot. 657. **A. Muthulingam, 110, Main Street, Badulla** - Applicant was living and engaged in business at 10, Main Street, Lunugala during the ethnic violence. On 29.07.1983 the inmates were chased away by a gang of thugs and the house and the shop were looted and burnt. Requests compensation. (Ref. 845)
658. **Mrs. L. Parimala, 146/1, Ranpahakagolla, Diyatalawa** - Applicant was living and engaged in business at 37, Badulla Road, Hali-Ela during communal riot in 1983. The house and the shop were looted and burnt on 29.07.1983 by looters. Seeks compensation. (Ref. 846)
659. **S. Appavoo, 196, Badulla Road, Hali-Ela**, -When the civil disturbances broke out the writer had resided at above address. He was the owner of Jayanthi Industries. On 29.07.1983 some stones were pelted at his home. Later a party of 150 persons damaged the property and some looted later the house and the industry was on fire. He had been badly affected in the 27th July 1983 disturbances. On that day when he was at Bank of Ceylon Office at Badulla his motorcyle had been burnt. The mob had attacked on his eyes with sharp instruments and so lost the vision. He also had a head injury. Requests relief. (Ref. 895)
700. **V. Sivalingam, Ali-Attamadawatta, Narangala, Hali-Ela** - He says that he was doing business at Dehigollakandura, Narangala, Hali-Ela at the time of the incident. On the 27.07.1983 his business premises and house attacked by a mob including his vehicle 35 Sri 1253, and his livestock were damaged and destroyed. Seeks compensation (Ref. 896)
701. **T. Chandiraratnam, 184, Lower Street, Badulla** - States that he was residing and doing business at No. 112, Lower Street, Badulla at the time of the incident on the 27.07.1983 his business premises and the house attacked by a large crowd looting his belongings and setting fire. 706. **A. Sivasamy, 1st Division, Spring Valley Group, Spring Valley** - Applicant was living in the above address during 1983 riots. Household goods were looted and the house was set on fire on 27.07.1983. Seeks compensation. (Ref. 902)
707. **P. Selvarajah, 1/4, A-5, Farm Road, Colombo 15** - Applicant was living at 4/10, Haputale Road, Bandarawela and engaged in business at 1, Main Street, Bandarawela in 1983. The shop was looted and burnt on 27.07.1983. The shop was looted and burnt on 27.07.1983 by the rioters, which forced the inmates to seek shelter at the St. Joseph's Refugee Camp. Requests compensation. (Ref. 903)
708. **Mrs. T. Elanayagi, 24th Mile Post, Kottabedda, Lunugala** - States she was living at the above address in 1983. They were chased away from the house and the household items were looted by a gang on 29.07.1983 during the riots. Requests compensation. (Ref. 905)
709. **Mrs. L. Sivanathan, 44-D, Ela Road, Kailagoda, Badulla** - Applicant was living and engaged in business at 11, Church Road, Badulla during 1983 riots. The above premise was attacked by a violent mob in July 1983, forcing the inmates to flee to the refugee Camp and later to Batticaloa, On return it was found that entire things belongs to the house and the shop were looted (Ref. 906)
710. **S. Soosaipillai, Swinton Division, m Showland Group, Lunugala** - He says that he was living at the above address during the riots. The occupants were chased away by a gang of looters on 27 July 1983 the house was set on fire and looting the household goods. Seeks compensation. (Ref. 907)

711. **Mrs. S. Araie, 150, Amunuwelapitiya, Deiyennewala, Badulla** - States she was living at 2nd Mile Post, Kurundugoa, Passara Road, Badulla during 1983. On 27.07.1983 the inmates fled to the refugees camp for safety when the huose was attacked by a gang. All the belongings were looted and also the applicant lost her 09 years old child who was seriously ill during the ordeal died without any medical attention. Requests compensation. (Ref. 908)

733. **T. Loganathapillai, 136, Sangamitha Mawatha, Colombo 13** - The writer had resided at the above address during outbreak of 1983 July communal disturbances. A part of his house, his furniture and the jewellery were set on fire and stolen. Requests compensation. (*Ref. 934*)

740. **S. Sothilingam, VC No. 171/A, Talatu Oya Road, Ampitiya** - Applicant was living at the above address running a bakery by the name "Jayalanka Bakery" closer to his house. Though police protection was sought by the applicant during 1983 riots it was not provided to protect his belongings and bakery which were looted and burnt on 28.07.1983. Seeks compensation. Seeks compensation. (Ref. 949)
748. **Mrs. S. Sivasothy, Kanda Junction, Unuwinna** - Applicant a widow, was living with her children at the above address during 1983. Due to ethnic riot in July 1983 she lost her livestock. Seeks compensation. (Ref. 950)
749. **Mrs. D. Periasamy, Valamalai, Ampitiya** - Applicant a widow was living in the above address during 1983 riots. On seeing an armed gang approaching their house they fled to the temple for safety. On return they have found that their entire belongings have been looted and burnt including poultry and cattle. Requesting compensation. (Ref. 951)
750. **Mrs. S. Saraswathy, 140/5, Tennewatte, Getawala, Leula, Ampitiya** - She States that she was living with her husband at the above address during 1983 riots. On 26th July 1983 the house was looted a gang of thugs after chasing the inmates away, and the house was set on fire, and their entire household good included jewelleryes were looted. Requests compensation. (Ref. 952)
751. **A. Tharmakulasingam, 4/2/2, Regent Flats, Sir Chittampalam A. Gardiner Mawatha, Colombo 02** - The writers states that his family was affected by the July 1983 ethnic violence. He had held a senior Executive Post as M/s Ceylon Synthetic Textile Mills Ltd. After the day of ethnic violence he lost his post and entire career. His household goods were lost at Wattala. coconut trees, coffee, cocoa, And peper plants. An they had livestock, Apart from that they had a Toffee Factory that was run by her son Mr. Siva Periyasamy. On the 26.07.1983 between 1.00 and 2.00 p. m. there was a crowd of approximately 50 people had come marching with rods, poles knives and swords, To save their lives they had to run out of the house to a close by jungle. When they view form the jungle they had seen that the house and factory burning. After that they went to the camp at Pillaiyar Kovil, Six or seven days after when they had come to see the house they saw one house was completely burnt and the other half damaged. 765. **K. Rajasingham, No. 83, Sea Street, Colombo 11**- He was living and working as Manager of K. V. R. Geetha Jewellery, at 397, Galle Road, Bambalapitiya until it was looted and burnt on 25th July 1983 during the disturbances Seeks relief. (Ref. 969)
766. **G. S. C. Shivakumaran, 290/1, Gemunu Mawatha, Rajagiriya**, - The writers had been and Electrical Engineer of Ceylon Electricity Board and was a resident at Kaldamulle Road, Ratmalana, On 25.07.1983 at about 3.00 p. m. 6 hooligans rushed to his house and they had fled the house in fear. They had burnt his car, looted the belongings and assaulted his father-in-Law. Seeks compensation (Ref. 970)
767. **A. S. Jayakody Mary, No 22, Isiyogama, Uswetakeiyawa**- The writer states that at the time of the breaking out of communal riots of July 1983 they resided at Gemunupura, Hunupitiya, Wattala. Their house was set on fire. They were

- displaced to Ratmalana Refugee Camp. Her husband had died subsequently. Requests compensation. (Ref. 971)
768. **N. Ponniah, J-3/6, Adnderson Flats, Narahenpita, Colombo 05** - The writer had been a clerks class I of the Auditor General Dept. and lived with his wife and 04 children at the above address at that time of July 1983 communal riots. On 24th July 1983 a gang of unknown men had threatened and attacked the home and the family had run away. His entire belongings were looted. Seeks relief. (Ref. 972)

800. **P. Marimuthu, 14-D, Kadugannawa Road, Gampola** - States that he was living with his family and engaged in business at "Sri Lanka Stores" Nuwara Eliya road, Ramboda, which was burnt down on 14.08.1981 due the racial riots. His

On 29.07.1983 at about 1.30 p.m. a mob had forcibly opened the house, pulled out all the belongings and burnt the house. He had worked as Assistant production Manager at Galent Industrial Paints Ltd. And his wife was employed as Stenographer at the Central Bank of Ceylon. Requests relief. (*Ref. 1022*)
803. **Felix Daniel Gnanaraj, CSI Diocese of Madras, 226, Cathedral Road, Chennai, South India**- The writer state that he had his family were severely affected by the ethnic riots on the night of 25th july, 1983. On 27.07.1983 at about 12.00 Noon ad mob had come and attacked their residence. The inmate of the house had to run away and take shelter at the refugee camp at Badulla Maha Vidyalaya, When the had come out of the refugee camp and seen that their residence had looted and destroyed. Seeks compensation. (*Ref. 1027*)

Harichandran, Ambagama Division, Hindagolla Group, Namunukula** - Applicant was living at 62, Nawalagama Road, Pallagettuwa and engaged in business at 8/2, Main Street, Pallagettuwa during 1983 riots. On 29th July 1983, both these premises were damaged and all the belongings were looted by thugs, simultaneously. Requests compensation. (*Ref. 1028*)
807. **K. Arumugan, 239A., Lower Street, Badulla** - The complainant says that he had been doing business at No. 4, South Lane, Badulla during the time of the incident. On 27.07.1983 at about 12.00 noon some unknown people had come



and attacked his business place. Through fear he had run away and on his return after some time he had found his business premises was looted. Seeks compensation (*Ref. 1029*)

808. **K. thangarajah, No. 16, Haskisan Road, Traincomalee**- Applicant's house was looted and completely burnt down on 26th July, 1983 during racial riots. All his belongings including jewelleryes were lost. Requests compensaiton. (*Ref. 1032*)

810. **O. Sellathurai, 13A, Ela Para, Spring Valley Road, Badulla** - States that he had been living at No. 36, Station Road, Badulla during the time of the incident. On 27.07.1983 at about 12.00 Noon a mob had come and attacked his residence and business place. Through fear he had run away and taken refugee at Badulla Maha Vidyalaya. Thereafter, on his return he had found that all his belonging had been looted. Seeks compensation. (*Ref. 1034*)
811. **S. Muthukaruppan, 110A, Pingalawa, Bandarawela Road, Badulla** - He says that they had been living at No. Eladaluwa Estate, Factory Divison, Badulla during the time of the incident. On 27.07.1983 at about 5.10 p. m. a mob of 50 people had come to attack him and attacked them . At that jungle they had run away fear of their lives to Badulla Maha Vidyalaya refugee camp. 813. **Mrs. T. Ramalingam, 60, Bank Street, Badulla** - Applicant was living and engaged in business at the above address in 1983, which was looted and set on fire on 27.07.1983 during the racial riot. Applicant housed at the Badulla refugee camp. Requests compensation (*Ref. 1038*)
814. **P. S. Singarajah, 373, New Passara Road, Badulla** - He says that he had a business place been at No. 299, Lower Street, Badulla during the time of the incident. On 27.07.1983 at about 12.00 noon a large group of mobs had come to his business premises to attack. They had run away fear of thier lives to Badulla Maha Vidyalaya refugee Camp. Thereafter, when they returned from the refugee camp they had found that their premises had been destroyed and their belongings were entirely looted. Seeks compensation. (*Ref. 1039*)
815. **S. Maruthu, Hopton Estate, Bangala Division, Lunugala** - The complainant says that they had been living at Swinton Division, Hopton Group, Lunugala at the time of the incident. On 27.07.1983 a mob of unknown people had come and attacked their residence. They had run away to the jungle under fear.

818. **R. Varatharai, 85/6, Eladaluwa Road, Mayilagastenne, Badulla** - He says that they had been residing at No. 44/4, Yampanawatte, Clinic Road, Badulla at the time of the incident. On 27.07.1983 some unknown people had come to attack them and through fear they had run out of the hose for safety. When they returned after few days they had found that their house was damaged and their personal belongings had been looted. Seeks compensation. (Ref. 1045)
819. **M. Vadivel, 41, Temple Road, Bandarawela** - The complainant states that he and his family were affected during July 1983 violence where his shop and house were burnt. Seeks compensation. (Ref. 1047)

On 28.07.1983 at about 12.30 p. m. a crowd of about 75 people advanced toward them and threatened all the inmates. through fear they had gone through the shrubs to Glen Alpin Estate. When they came back on 30.07.1983 they found that their entire house had destroyed and its belongings were looted. Seeks relief. (Ref. 1049)
822. **Mrs. M. Sarojadevi, C/o, Rengadevan, "Subash Cafe", No. 15, Bandarawela Road, Badulla** - The complainant says that they had been residing at

Aluthwatte, Ulugala, Bowela, Welimada at the time of the incident. On 28.07.1983 a crowd had come and attacked and looted their house set fire to it. Request compensation. (*Ref. 1050*)

835. **K. V. Muthuramalingam, Parambe Estate, Undugoda** - The writer states that during the disturbances of July 1983, his hose was burnt and all valuable items looted. Seeks relief. (*Ref. 1081*)
836. **M. Carlin Silva, 1037, Maradana Road, Borella, Colombo 08** - Applicant was working as a barber at "Elphinston Saloon" and residing in the said saloon at No. 07, Panchihawatte Road, Colombo 10, which was looted during 1983 riot along with applicant's belongings and cash. Siddiques, 15/3, Heeresgala Road, Kandy** - Applicant is claiming compensation for the Bakery and the stores at No. 18, 4th Cross Street, and No. 21, 5th Cross Street, which were gutted by fire completely on 25th July 1983 and the sole proprietor was applicant's father Mr. M. 841. **N. Kathiravel, 1, Wooden Bazaar, Kotagala** - Applicant was living with his family in udapakai Estate, Baralangoda, Deraniyagala in 1983. He was chased away from the above premises ; by a gang of looters on 30.07.1983, it was later found that the hose was completely burnt down. Requests compensation (Ref. 1095)
842. **C. Ramanathan, Akroya Bazaar, Rozella** - Applicant's house was looted and burnt down by army and looters on 29.07.1983. Requests compensation. (Ref. 1096)

Varatharajah, 83, Sea Street, Colombo 11** - States he was living at 397, Galle Road, Bambalapitiya with his family and running a jewellery shop adjoining another jewellery shop by the name "K. V. R. 845. **N. A. Ramanathna, 39/4, Nimalamaria Mawatha, Hendala, Wattala** - Applicant was living with his family at 638/13, Mabola, Wattala during the 1983 riots. Shanmugam, 446, Main Street, Haldummulla Haputale** - States that they were residing and doing business at the premises number 444, Main Street, Haldumulla during the time of the incident. On 29.07.1983 at about 7.40 p. m. an unruly group had come to attack them. Thereafter they had to run away to save their lives. His business premises was burnt and entire things were looted. 862. **Mrs. Gopalapillai, 20/1, 4th Lane, Uvarmalai, Trincomalee** - Applicant was living at 6th Canal Road, Pankulam and affected in 1977, 1983, 1987 and 1990

displaced and now returned to her permanent place. Being a widow and sick person and had lost her house and belongings due to violence. Requests compensation. (Ref. 1127)

873. **T. Rajagopal, 908, Aluvihare, Matale** - The complainant states that his entire belongings were looted when they were reside in a rented house during the riots. Requests compensation. (Ref. 1143)

Arunasalam, Gowrakelle Estate, NC Division, Demodara** - He States that they were dwelling at Pingarawa Esate, Pinarawa Division, Namunukula at the time of the incident that took place in July, 1983. Thereafter the inmates fearing and to safeguard their lives had ran away form the house. 876. **R. Canagaratnam, D 11/4, UNHCR Refugee Camp, Alles Estate, Trincomalee** - He states that he had been living at 5th Canal, Morewa, Pankulam prior to 1990. He had been affected by riots that took place in the years 1977 to 1990 making him to disown his house and personal belongings. Requests compensation. (Ref. 1160)
877. **B. P. Rajan, VC- 171/1, Pallegama, Ampitiya Kandy** - He states that he was residing at the above address with his family members . Due to the tension that prevailed in the country on 24.07.1983 they were living under fear. At about 7.00 p . m. when a violence mob tired to entire their house, they had escaped and hid themselves in the jungle area of their property and spend the whole night. The next day morning they had gone to Ampitiya St. Mary's Catholic Church and then from there they went to the Kandy Sri Vinayagar Temple as refugees. After spend few days in the camp they returned to their house. they saw their house was partly burnt and their belongings were completely looted. Requests compensation. (Ref. 1165)
878. **S. Rasiah, VC 171/1, Pallegama, Ampitiya, Kandy** - He states that he was residing at the above address with his family members. Due to the tension that prevailed in the country on 24.07.1983 they were living under fear. At about 7.00 p. m. when a violence mob tried to enter their house, they had escaped an l hid themselves in the jungle area of their property and spend the whole night. The next day morning they had gone to Ampitiya St. Mary's

- Catholic Church and then from there they went to the Kandy Sri Vinayagar Temple as refugees. After spending a few days in the camp they returned to their house, they saw their house was partly burnt and their belongings were completely looted. Requests compensation. (Ref. 1166)
879. **K. Arulampalam, 1/1, Madangahawatte Lane, Wellawatte, Colombo 06** - States that he was living at No. 1/1 Madragala Lane, Off Arethusala Lane, Wellawatte, which was looted on 25.07.1983. All his belongings were looted and destroyed. Requests compensation. (Ref. 1176)

884. **P. S. Bahulesan, A-2/4, Denister De Silva Mawatha, Colombo 09** - States that they had faced destruction of their properties by the 1983 July disturbances. They had been living in the above premises for many years. He has 4 children and he is suffering from ailment. Requests compensation. (Ref. 1188)
885. **Mrs. Thilakeswary Ganeshan, 187/16, Jayasamagi Mw. Kalubowila, Dehiwala** - Complainant states that during 1983 riots she had suffered a lot where she lost all her belongings. She seeks compensation. (Ref. 1189)
886. **Ms. Fareen Bagus, 66/15, Baseline Mawatha, Dematagoda, Colombo 09** - Applicant's husband was shot dead during 1983 riots and from that day onward she is suffering without any assistance. Requests compensation. (Ref. 1191)
887. **P. Subramaniam, 11, Kuruwewa, Rattota** - Applicant was living with his family at Hunnagiriya, Udadumbara during 1983 riots, where his house was attacked, looted and burnt on 28.07.1983. Requests compensation. (Ref. 1192)
888. **Mrs. Indrani Joseph, 271/90, Church Lane, Mutuwal Colombo 15** - States she was living at 11/4, Fatima Lane, Walikurunduwatte, Ja-Ela and had lost her

- household belongings when the house was set on fire due to violence in 1983. Requests compensation. (Ref. 1196)
889. **S. Velupillai, "Subramaniam, Stores", 5, Main Street, Haputale** - Applicant was running two business establishments with his family members at No 03, and No. 05, Main Street, Haputale namely "Subramaniam & Stores", and "Subramaniam Stores", When these were looted and set on fire during ethnic violence on 27.07.1983. Requests compensation. (Ref. 1197)
890. **Mrs. S. Mangaietkarasi, 1/9, Brindawela, Aluviharaya, Matale** - Applicant was living at Matale when her house was set on fire on 29.07.1983 during ethnic violence. This application is forwarded on behalf of the mother (S. Meenatchi) Requests compensation. (Ref. 1198)
891. **K. K. Chandradasa, 42, Wellawaya Road, Moneragala** - Applicant states that he was running a tea boutique at 18, Wellawaya Road, Moneragala when it was set on fire and all belongings destroyed on 30.07.1983. Seeking assistance to re-establish the business. (Ref. 1199)
892. **K. B. Chitra, 7th Mile Post, Debedda** - Applicant states that he was living at 219, Lower Street, Badulla in an upstairs building when it was set on fire on 27.07.1983 during ethnic violence. Requests compensation. (Ref. 1200)

897. **M. A. Chandrasegar, 131, Nagastenne Road, Kandy** - He was running a bag business at 282/17A, Vella Street, Colombo 12 (Dam Street) when it was looted on 25.07.1983 due to ethnic violence. Requests compensation. (Ref. 1209)
898. **A. Sivagnanapragasam, 132/2, Sri Sidharatha Road, Kirulappone, Colombo 05** - Applicant states that he was living with his parents at 57, Kasakahawatta

- Road, Wattala when it was attacked and burnt with belongings on 26th July 1983. Requests compensation. (*Ref. 1211*)
899. **M. P. Moses, No. 11-A, 11th Lane, Marrikar Street, Puttalam.**- States he was living at Chenakudiruppu, Puttalam when his house was destroyed with household belongings on 5th December 1984 due to communal riots. Seeks compensation. (*Ref. 1212*)
900. **P. Mohandas Gandhi, 226, 2nd Floor, Modern Complex, Lower Street, Badulla** - Applicant states that he was living at 7, Lower Street, Badulla which attacked and looted on 27th July 1983 during racial riots, forcing the applicant to enter the refugee camp with his family. Requests compensation. (*Ref. 1214*)
901. **P. Periyasamy, 154, Kathirsam Street, Colombo 13** - Applicant was living with his family at 20/1, Nimala Mariya Mawatha, Wattala engaged in metal business by the name "Jeyalanka Metal Stores" at 146/1, Negombo Road, Peliyagoda where both these places were looted and burnt on 25th July, 1983 during the violence. Requests compensation. (*Ref. 1222*)
902. **N. Velautham, 61, New Boundry Road, 2nd Cross, Sinnha Urani, Batticaloa** - States that he was living with his family engaged in business by the name "New Siva Stores" at 546, South Lane, Badulla which was looted and set on fire on 27.07.1983 due to the ethnic violence. Displaced to Eravur (E. P.) and there also his business was destroyed. Requests compensation. (*Ref. 1224*)
903. **P. Balasubramaniam, 21, Yalbede Road, Jayawickrama Mawatha, Haputale** - Applicant states that he was living and running a business establishment at No. 08, Haputale Badulla Road, (textile pawning shop) when it was looted and set on fire on 27.07.1983 during the ethnic violence. Requests compensation (*Ref. 1225*)
904. **A. Manivel, 10, Hanifa Stores, Deraniyagala** - Applicant states that he had displaced during the July 1983 ethnic violence and had lost his entire movable properties. Requests compensation. (*Ref. 1227*)
905. **A. Durairaj, 237/1, Negombo Road, Wattala** - Applicant was living with his family at 94, St. Mar's Lane, Mattakuliya engaged in business at Mattakuliya Junction, when his house and business place were attacked and looted on 25th July 1983, and also damaging the vehicle No. 26 Sri 6922. Requests compensation. (*Ref. 1228*)
906. **V. Sivalingam, 287/11, Fegusan Road, Colombo 15** - Applicant was living at 64/35, Modera Street, Colombo 15 and having a sotre at 37, Nelligadawatte, Negombo Road, Peliyagoda and a Paint Industry at 67/A, Bloemendahal Road, Colombo 15, when these were set fire and burnt tr ashes on 25.07.1983. Requests compensation. (*Ref. 1229*)

907. **Mrs. Vahiri Balasubramanian, Sylvery Tyre Dealers, 12, Cocomwatte Road, Badulla** - Her father was an employee at "Tata Company" at 139, Main Street Bandarawela (now deceased) when it was set on fire with all the goods on 27.07.1983 during 1983 riots. his belongings were destroyed . Requesting compensation for the lost items. (*Ref. 1230*)
908. **P. Muthuraj, 6, Hindagoda, Badulla** - Applicant states that his firm by the name "Mutharas" was looted and set on fire during 1983 riots. Request compensation. (*Ref. 1231*)
909. **P. Vethanathamoorthy, 327, Badulla Road, Hali-Ela** - Applicant complains that he had been badly affected during 1983 racial riot. Requests compensation (*Ref. 1232*)
910. **R. Ramachandran, 19, Central School Road, Passara** - States he was residing at 19, Sangabo Mawatha, Passara carrying business at 333, Main Street, Passara by the name "Sri Ram Stores" which were damaged, looted and burnt down on 28.07.1983 due to violence. Requests compensation. (*Ref. 1233*)
911. **C. Kanagaratnam, 29, Rattota Road, Matale** - Applicant was residing at 254, Mantahandawela, Matale when it was attacked and looted on 28.07.1983 due to communal disturbances. Requests compensation. (*Ref. 1237*)
912. **R. Loganathna, Makulagaharuppa, Palapatwela** - States that he is a retired Principal. His family had been affected by the incident that took place during 1983 riot. His house was completely burnt down and gutted. Requests compensation. (*Ref. 1238*)
913. **K. V. Arasaratnam, 232/2, Badulla Road, Bandarawela** - He states that his family had been affected by the incident that took place during 1983 communal riot. His entire belonging and valuables were looted and destroyed. Requests compensation. (*Ref. 1239*)
914. **A. Kandappa, 6/4, Cambridge Place, Colombo 07**- Complainant states that he was owning a large business establishment in Maradana and during 1983 riots his establishment was damaged and thereby he suffered severe loss. He wish to give evidence before the commission and seeks adequate compensation for the losses suffered. (*Ref. 1240*)
915. **V. Arumugam, S- 2/4, De Soysa Flat, Moratuwa** - Applicant he was living with his family at the above premises which was attacked and looted on 25th July 1983. They were forced to move out to refugee camp at Ratmalana, and had to stay there as a refugee until the situation calmed down. He had lots all his valuable things and household items. Seeks compensation. (*Ref. 1241*)
916. **D. H. Jayaratne, 19/1, 2nd Lane, Vidharashana Mawatha, Galewilawatte, Homagama**, - He states that he was running a tailoring shop at 106, 2nd Cross

street, Pettah, which was looted on 25th July 1983 after he left the place for safety. Requests compensation. (Ref. 1242)

917. **S. Sathiyamoorthy, 19/1, Welimada Road, Bandarawela** - Applicant, Vice-Chairman of U. C. Bandarawela was running a repair shop at 227, Main Street, Bandarawela, which was looted and destroyed on 28.07.1983. Requests compensation. (Ref. 1243)
918. **S. K. Sivagnanam, Galgewater, Pahala Kottaweva, Welimada** - States that he was living with his family at the above premises when it was attacked by a mob of looters on 27th July 1983 and set on fire. His entire belongings were destroyed and looted. Seeks compensation. (Ref. 1244)
919. **P. Kathiresan, 100, Main Street, Rakwana** - He states that he was residing at 239, Galle Road, Colomobo 06 during the time of the ethnic violence that took place on 25th July 1983. He had sustained loss of items such as jewellery, cash, and clothes, Requests compensation. (Ref. 1247)
920. **T. Rejendran, Delveen B-Division, Rakwana** - States that he was running a shop at 213, Kanuwana, Ja-Ela with two others collecting sacks, empty bottles, gunny bags, plastic cans, copper, brass and iron etc. during the time of the ethnic violence. On the 25th July 1983 at about 7.00 a. m. he had opened the shop for business and thereafter, by 12.30 p. m. he had closed the shop because of the communal tension that prevailed on that day. On the same day at about 8.00 p. m. approximately 200 unknown singhalese people had come, forcibly opened his shop and had looted and set on fire to unusable things. His personal documents and things had got destroyed. Seeks relief. (Ref. 1248)
921. **Mrs. P. Annaletchumy, 16/8, Lower King's Street, Badulla** - The applicant writes to say that they had been affected by the ethnic violence. On 27.07.1983 at about 11.30 p. a. a group of 200 hooligans had come and attacked their house and their belongings. Requests compensation. (Ref. 1252)
922. **Mrs. T. Arulanantahm, T-8, Anderson Flats, Narahenpita, Colombo 5** - The applicant attached to Bd/Saraswathy Central College writes to say that his family was affected in the ethnic violence in the year 1983 and they at the Badulla camp as refugees. At the time of the incident her house and the property too were completely destroyed. As a result her family got displaced and they settled in Badulla District since the year 1983. They had become refugee and were moving from place to place. Requests compensation. (Ref. 1253)
923. **Mrs. C. Kanthimathy, 232/1, Badulla Road, Bandarawela**, -Applicant says that they were living at 234/2, Badulla Road, Bandarawela at the time of the incident that took place in 1983. On 27.07.1983 at about 4.00 p. m. on witnessing a mob approaching towards their premises they had left the house without taking any of their belongings. When they returned after some times they found that all their belongings had been looted. Seeks compensation. (Ref. 1254)

924. **Mrs. A. Philominas Rosairo, 48/20, Wewetenne Road, Bandarawela** - States that she was staying at 48/20, Wewetenne Road, Metipimpiya, Bandarawela during the time of the incident in July 1983. On the 27.07.1983 at about 6.00 p. m. a gang of thugs had come and attacked Tamil community house. On hearing and seeing this to save her life and her daughters had gone and hidden in the drains. On the following morning Bandarawela Police had taken them to St. Joseph College, Bandarawela. They had been there about 45 days, They had undergone sever hardship during their stay in the camp. After leaving the camp they had gone to their house and had found that their Jewellery, clothings, utensils and sewing machines were missing. Seeks relief. (Ref. 1256)
925. **Ms. T. Kodeeswary, C/o, T. Sundararajah, "Singal View", 24/1, Deiyannawela Road, Badulla** - The applicant says that he had a sugar cane farm and the machineries at the time of the ethnical violence in July 1983. On 27.07.1983 his farm and the machineries had been looted and burnt. He had been in the Welfare camp at Badulla Maha Vidyalay from 01.08.1983 to 04.08.1984. He had sustained loss of movable and immovable properties. Requests compensation. (Ref. 1257)
926. **Mrs. R. Parawathy, 72/10, Sri Maha Vihara Road, Kalubowila, Dehiwela** - Complainant states that during 1983 riots she and her family suffered a lost where their house was looted and burnt. She seeks compensation (Ref. 1258)
927. **George R. Robert, 48-A, Second Lane, Ratmalana** - He says that he was residing at 47/12A, Perera Mawatha, Talangama south, Talangama. He was living with his Sinhala domestics who had four children for over two generations. On the 26th July 1983 at about 12.00 noon he had anonymous telephone call that a group of people were planning to destroy his and his residence. His house was looted and his vehicles - Misubishi L 300 van and car, standard ensign 3 Sri 5118 were too got burnt. He had sought refuge with his neighbour . Afterward had stayed with his several friends and later in refugee camp. As last resort he had moved to his late younger brother's house at 48A, Second Lane, Ratmalana in their annex where he lives at present. Seeks compensation. (Ref. 1259)
928. **V. Kottaiya Alias Raman, 6/2, Jalasa Road, Bandarawela** - He says that he was residing at 51/1, Jalasa Road, Bandarawela at the time of the incident with his wife and 6 children in July 1983. ON the 28.07.1983 at about 9.00 a. m. he had seen a crowd standing on the road and approaching towards his house. Seeing that he had taken shelter with his family at Kathiresan Kovil, Bandarawela. He had taken with him the Transistor Radio, few of their clothings. When they were at the Kovil suddenly a mob armed with clubs and iron bars had come and attacked the people there. On seeing the crowd he had run and taken refuge with his family at St. Joseph's College. When he had gone and inspected his house and had found his and been broken, windows smashed, and to find many of his articles are missing . Seeks relief. (Ref. 1260)
929. **N. Arumuganm, "Mantex Traders", 106-F, Second X street, Colombo 11** - The applicant says that he was carrying on textile business at the above

address during the period of ethnic violence in 1983. On the 25.07.1983 at about 9.45 a. m. a mob had started attacking and looting almost all the shop in the Jeyaraj Cross Street, Colombo 11. At the time of the attack he and his salesman also had to run away from the shop to safeguard their lives. When they had returned after one week they had found that their stock in trade had been looted. Seeks compensation. (Ref. 1261)

930. **K. Pathmanathan, 239/A, Lower Street, Badulla** - The applicant says that he was carrying on business at the above address during the period of ethnic violence in 1983. On the 27.07.1983 some people had started attacking and through fear he had run away leaving the business premises. Later on this return he had found that his shop was set on fire and completely burnt down. Requests compensation. (Ref. 1262)
931. **Mrs. Ramasamy Chithrayee, 65, Molandapitiya Road, Matale** - She says that she was living at Lognagara Estate at the time of the ethnic violence in 1983. On the 27.07.1983 his residence was set on fire and its belong were completely destroyed. During the incident with the help of her neighbours she had taken shelter at Matale Pattini Kovil or about 15 days. Later she had sold the 02. acres of land that was attached to the residence and had to spend on living and children's education. After that she had to rent a house at Warakamura, At present she lives in a house that belongs to one of her children. Seeks relief (Ref. 1263)
932. **P. Ramiah, C/o, Nandasiri Pascal, 9, Sri Devananda Road, Matugama** - He says that he was running a textile shop at Old Matugama Town at the time of the ethnic violence in 1983. On the 25.07.1983 his shop and some other shops were set on fire. At that time there were goods worth of Rs, 100,000 that were from Colombo to his shop and another set of goods that belongs to the shop worth about Rs. 250,000. The next day he had heard that his stock in trade had been completely destroyed by fire but could not go and see what happened. His wife had fallen sick then. After loosing all his belongings, requested a room in an estate at St. Jorge Estate to shelter his family. Since then he had to lead a miserable life in bringing his younger ones ; sending to school, attending to illness. From that day he is involved in sewing children dresses and selling it to house to house to sustain his family life. Some days he had forego one or two meals. Seeking assistance to obtain a piece of land at leave put a small hut to live. (Ref. 1264)
933. **L. Somasundaran, 166, Kings' Street, Matale** - He says that he was living with his wife and three children at the above address. On the 29.07.1983 exactly at about 2.00 p. m. the crowd that had gathered in front of their house started pelting stones at their residence and attacked with batons; they entered the house forcibly and poured fuel and started setting fire. The inmates had to run away without taking any belongings to safeguard their lives. They took refuge in a Muslim house later they had taken to Zahira College refugee camp. After few days they had gone to see the house. When they went there they found



that their house was left only with walls. All the belongings had been looted and destroyed by fire. Requests compensation. (Ref. 1265)

934. **Mrs. Margaret Cruz, 232/1, Badulla Road, Bandarawela** - States that they were staying at Lowland Estate, Ellatota, Bandarawela during the time of the incident of July 1983. On the 27.07.1983 at noon, nearby house of Dr. Nathaniels house was attacked and set on fire. Due to the incident Mr. and Mrs. Nathaniels were burnt alive. Seeing that they had got frightened wondering what to do they had rushed to their stepmother's house, which is situated at Badulla Road, Bandarawela. Unfortunately fearing the situation they also had closed their residence and gone somewhere to save their live. They had to hide nearby bamboo bush for their safety. The next day they had taken refuge at St. Joseph College, Bandarawela. Since then the applicant's deceased husband had got stroke and suffered mental retardation Seeks relief. (Ref. 1266)
935. **L. Pathmanathan, 168, King's Street, Matale**- He says that they never expected that type of ethnic violence would happen. On the 29.07.1983, his residence was pelted with stones and the rioters started attacking them. Having thought that it was unsafe to continue to stay there they had left the residence through the back door and take refuge in a muslim house near by, after that they had taken to Zahira College refugee camp. When they returned home, to their surprise their house was not in the condition what they expected. The house was roofless. They had lost all their belongings including their jewellerys. Requests compensation. (Ref. 1268)
936. **S. Rajasekeram, No. 23, 42nd Lane, Colombo 06** - He says that he was residing at No. 54, E. S. Fernando Mawatha, Colomob 06 at the time of incident in 1983. His house had been attacked and all their movable things were looted during July 1983 riots. Requests compensation (Ref. 1269)
937. **Mrs. S. Kailasanathan, C/o. Mrs. Raju, 50/58, Hekitta Road, Wattala** - The applicant states that they were living at No. 21, Pillaiyar Kovil Road, Matale during the time of ethnic violence in 1983. Due to the arson setting fire to her residence she had incurred loss. Requests compensation. (Ref. 1274)
938. **S. Govindasamy, No. 20, VC Quarters, Poonagala Road, Bandarawela** - Says that he was living at No. 09, Pansala Road, Bandrarawela at the time of the incident in 1983. On the 27.07.1983 at about 3.30 p .m. a gang of thugs had come set fire to their house causing a portion of their house to be burnt with its belongings.
